**YMCA of Niagara Announcement  
New purchaser for the Walker Family YMCA and final stage of sales process**

**(St. Catharines, ON)** – The YMCA of Niagara is pleased to announce they have entered the final stage of the sales process for the Walker Family YMCA. Having completed the conditional review phase of the process, the formal sale of the property at 25 YMCA Drive is expected to be concluded soon. Today, the YMCA is pleased to announce the purchaser for this property which is **Atria Development Corporation**.

Atria is fast becoming one of Southern Ontario's pre-eminent development companies, creating new single and multi-phase communities in Peterborough, Oshawa and Toronto, as well as Barrie, Hamilton and St. Catharines. Family-owned and community-focused, Atria is distinguished through its commitment to enriching the neighbourhoods where it builds, catalyzing economic activity and stimulating positive social change. The company also believes deeply in adaptive reuse, the repurposing of locally valued but underused structures, an expression of Atria's environmental stewardship and community focus. The company has recently completed two residential projects associated with YMCAs in Ontario comprising 750 rental units; Y Lofts, an adaptive reuse of a heritage YMCA building in Peterborough and a two phase Bond Street project in Oshawa (100 Bond and 80 Bond), where residents receive a membership to the adjacent Oshawa YMCA during their tenancy.

"We are keen to work with the YMCA to see how this location could be potentially renewed and redeveloped with Atria's experience, knowledge and capabilities in order to enhance the community in St. Catharines" says Hans Jain, President of Atria Development Corp.

The YMCA is excited to work with such a creative property developer. Mike Watt, YMCA Board Chair states: "There is opportunity for us to explore the possibility of future collaboration and program delivery with our new property owners at this location in addition to our ongoing research related to new and innovative program models and locations across St. Catharines."

The YMCA has also been in collaborative discussions with the City of St. Catharines throughout this process. Said Mayor Walter Sendzik "The purchase of this property by Atria Development will be a win-win for our St. Catharines community, providing the opportunity to develop quality purpose built-rental and condominium units and creatively explore new ways to leverage this asset as an ongoing "Centre of Community" for future residences and programming. We look forward to ongoing discussions"

In March of 2021, the YMCA of Niagara announced the listing of the Walker Family YMCA for sale, sighting increasing financial pressure amidst dwindling membership numbers and rising maintenance costs for the 27-year-old centre that hosted a range of fitness facilities, as well as licensed childcare and EarlyON programs.

At that time, Mike Watt, Board Chair explained “We truly believe that the sale of the Walker Family YMCA is a step we must take to guarantee the long-term financial sustainability of the Association helping to ensure we can continue serving the community of St. Catharines and the Niagara Region for many years to come”. Positioning the sale as a necessary measure, the Walker YMCA closed to the public during the pandemic but opened during a brief window of time in the fall of 2020 before closing again on December 26, 2020. Since then, full health, fitness and aquatics memberships have not resumed although selected programs and services have been offered from this location.

More recently, in August of 2021, YMCA of Niagara CEO Steven Chuang announced that a qualified purchaser had stepped forward and the YMCA had entered a conditional review stage with them while continuing to explore ongoing and future opportunities to provide programs and services to the St. Catharines community. Steven Chuang emphasized even if the building was sold, it would not mean the end of YMCA programming in the city. "When the building does get sold the proceeds will allow us to reassess the conditions of health, fitness, aquatics, and whole recreational programming in St. Catharines and the Niagara Region, and how to reinvest back into a new post-COVID world."

The YMCA will provide updates on next steps once this process is completed and would like to thank Colliers International for their help with the sale.

All other YMCA of Niagara Health, Fitness and Aquatics locations in Port Colborne, Niagara West and Welland resumed full operations this fall, and recently transitioned to offering virtual programming during the provincial lockdown; these locations will be reactivated for in person service as soon as the provincial restrictions allow. YMCA Licensed Infant, Toddler and Preschool Child Care Programs remain uninterrupted. YMCA Licensed Before and After School Care will resume when the schools reopen. YMCA Employment and Immigrant Services, EarlyON and Community Outreach Programs are now operating under a virtual model while under lockdown and are expected to resume in person operations as soon as possible.
